Sub: Postponement of 29th e-auction scheduled to be held on 20/09/2018 – reg.

Sir,

Kind reference is made to this office letter No. AAM/CARGO/DISP/3146/29/2018/3816-21, dated. 04/09/2018, wherein permission for grant of NOC for unclaimed/Uncleared / inventorised consignment for conducting e-auction on 20/09/2018 with display on 19/09/2018. (Less than one year & more than one year cargo pertains to the period July 2017 to December 2017).

AAICLAS has processed less than one year old cargo also, for which the Valuation/Reserve price also to be approved by Customs authority as per the regulations. Since 10% inspection as well as NOC and specific approval for Value/Reserve price. for less than one year cargo , received till date, it is difficult to proceed further as any last minute withdrawal will result in modification of lot value in MSTC website through Valuer.

Further, for 27th e-auction Customs has given OOC only on late evening of 15/9/2018 after much persuasion i.e. after 107 days of filing BOE on 01/06/2018. In the meanwhile, the agency M/s. Dynamic Prime Exports forwarded a mail to the Chairman, AAICLAS complaining the delay in delivery of sold lots in the 27th e-auction held on 22/03/2018 and conveyed the message on behalf of 07 probable bidders about their non-participation in the ensuing 29th e-auction to be held on 20/09/2018 (Copy enclosed).

In view of all the above, and in absence of NOC from Customs UCC cell till date AAICLAS is forced to postpone the 29th e-auction scheduled on 20/09/2018 with display date on 19/09/2018 for a week's time and the same may be conducted on 28/09/2018 with the display on 27/09/2018 duly with Customs NOC in the meanwhile.

Therefore it is requested that NOC & approval of Value/ Reserve price may be given by Customs on or before 25/09/2018 positively.
